Receiving accreditation from the National Institute of Occupational Safety and Health Certification (NIOSH CERT), the certifications are in Occupational Health and Safety Management System (ISO 45001) and Environmental Management System (ISO 14001).

The accomplishment underscores SPSB's strong commitment towards providing a safe workplace environment for its employees and ports users as well as minimizing environmental impact of its operations by adopting internationally recognized standards managed by an effective quality management system.

Lost Time Injury is categorized as incidents that result in a disability or an employee missing work due to an injury.
